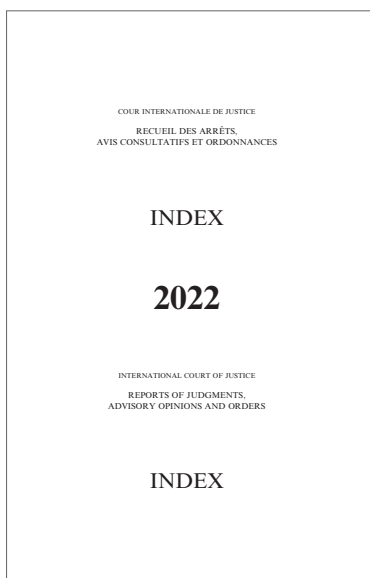


### Bibliography of the International Court of Justice
