# **DESCRIPTION OF REQUIREMENTS**

1. It is anticipated that the Procurement Unit of the International Court of Justice (ICJ) will shortly be issuing a solicitation on the above subject.

In this context, the International Court of Justice (ICJ) is seeking expressions of interest from qualified companies for a book printing and finishing project, in accordance with the following specifications:

- **Printing**: black and four-color process
- Binding: sewn paperback and sewn hardback (full cloth)
- Collections: single 156 x 240 mm format
- Paper: coated ½ mat 80 gr/m<sup>2</sup>.
- **Paginations**: between 352 and 1,152 pages per book
- Estimated annual quantity: approx. 4,000 copies, distributed over 12 references per year
- Books outside collections: variable definition, one volume per year on average

**Environmental requirements**: Suppliers must demonstrate their commitment to environmentally friendly practices.

**Contract duration**: 3 years, renewable.

## **Instructions to suppliers**

Interested companies must submit an expression of interest that includes:

- 1. A one- to two-page description of the company's profile, highlighting its technical, logistical and financial capabilities.
- 2. Relevant details of experience gained in similar projects, specifying major references.
- 3. Information on their technical and logistical capacity to meet the above requirements.
- 4. UNGM registration number.

No supporting documents or copies of certifications are required at this stage. Please note that this expression of interest is only intended to identify qualified companies. Only companies selected after rigorous evaluation will receive official tender documents.

- This expression of interest is not an invitation to submit a bid.
- This EOI does not constitute an invitation to tender.
- The ICJ reserves the right to select companies on the basis of an objective evaluation of the bids received.
- Only vendors registered on the United Nations Global Marketplace (UNGM) will be able to receive tender documents.

## 1) Registering as a Vendor with the United Nations

Vendors interested in fulfilling the requirement described above must be registered at the UN Global Marketplace (www.ungm.org) with the UN Secretariat in order to be eligible to participate in any solicitation. # **Prerequisites for Eligibility**

In order to be eligible for UN registration, you must declare that:

- A. Your company (as well as any parent, subsidiary or affiliate companies) is not listed in, or associated with a company or individual listed in:
- I. the Compendium of United Nations Security Council Sanctions Lists (https://www.un.org/securitycouncil/content/un-sc-consolidated-list), or
- II. the IIC Oil for Food List website or, if listed on either, this has been disclosed to the United Nations Procurement Division in writing.
- B. Your company (as well as any parent, subsidiary or affiliate companies) is not currently removed or suspended by the United Nations or any other UN organization (including the World Bank);
- C. Your company (as well as any parent, subsidiary of affiliate companies) is not under formal investigation, nor have been sanctioned within the preceding three (3) years, by any national authority of a United Nations Member State for engaging or having engaged in proscribed practices, including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice;
- D. Your company has not declared bankruptcy, is not involved in bankruptcy or receivership proceedings, and there is no judgment or pending legal action against your company that could impair your company's operations in the foreseeable future;
- E. Your company does not employ, or anticipate employing, any person(s) who is, or has been a UN staff member within the last year, if said UN staff member has or had prior professional dealings with the Vendor in his/her capacity as UN staff member within the last three years of service with the UN (in accordance with UN post-employment restrictions published in ST/SGB/2006/15).



F. Your company undertakes not to engage in proscribed practices (including but not limited to: corruption, fraud, coercion, collusion, obstruction, or any other unethical practice), with the UN or any other party, and to conduct business in a manner that averts any financial, operational, reputational or other undue risk to the UN.

For Registered Vendors: Vendors already registered at the UN Global Marketplace with the UN Secretariat must ensure that the information and documentation (e.g. financial statements, address, contact name, etc.) provided in connection with their registration are up to date in UNGM. Please verify and ensure that your company is registered under its full legal name.
