#### Request for the indication of provisional measures

### Court to deliver its Order on Wednesday 16 July 2008 at 3 p.m.

THE HAGUE, 11 July 2008. On Wednesday 16 July 2008, the International Court of Justice (ICJ), principal judicial organ of the United Nations, will give its Order on the request for the indication of provisional measures submitted by Mexico in the case concerning Request for Interpretation of the Judgment of 31 March 2004 in the Case concerning Avena and Other Mexican Nationals (Mexico v. United States of America).

A public sitting will be held at 3 p.m. in the Great Hall of Justice of the Peace Palace in The Hague, during which the President of the Court, Judge Rosalyn Higgins, will read the Court's Order.

#### NOTE TO THE PRESS AND PUBLIC
