Proceedings instituted by the Republic of Costa Rica against the Republic of Nicaragua

Request for the indication of provisional measures

The Court to hold public hearings from Tuesday 11 to Thursday 13 January 2011

THE HAGUE, 7 December 2010. The International Court of Justice (ICJ), the principal judicial organ of the United Nations, will hold public hearings in the proceedings instituted by the Republic of Costa Rica against the Republic of Nicaragua, from Tuesday 11 to Thursday 13 January 2011, at the Peace Palace in The Hague, the seat of the Court.

The hearings will be devoted to the request for the indication of provisional measures filed by Costa Rica (see Press Release No. 2010/38).

NOTE TO THE PRESS AND PUBLIC

1. The public hearings will be held in the Great Hall of Justice of the Peace Palace. Mobile telephones are permitted in the courtroom provided they are switched off. Any offending device will be temporarily retained.
