The Ministry of Foreign Affairs Malaysia presents its compliments to the High Commission of the Republic of Singapore and strongly protests the violation of Malaysia's airspace over its territory and waters off the coast of the State of Johor by Singapore government aircraft, including but not limited to the following incidents:

- i. Between 0930 hrs to 0932 hrs on 4 October 2010 by Singapore government aircraft SQUAQWK Mode 3 4614; and
- ii. Between 0922 hrs to 0958 hrs on 8 October 2010 by Singapore government aircraft SQUAQWK Mode 3 4612.

In view of the above, the Government of Malaysia reiterates its strong objection to the presence of aircraft belonging to the Government of the Republic of Singapore in Malaysia's airspace off the coast of the State of Johor.

The Government of Malaysia further wishes to reiterate its categorical rejection of Singapore's designation of Restricted Area WSR 31 from an altitude of 3,500 feet to 10,000 feet within Malaysia's airspace, over its territory and waters off the coast of the State of Johor, without the prior consent of the Government of Malaysia. The designation by the Republic of Singapore of the said airspace as a Restricted Area without the prior consent of the Government of Malaysia is inconsistent with international law, in particular the Convention on International Civil Aviation (Chicago Convention) 1944, and is in fact an abuse of Singapore's administrative powers as the Flight Information Region authority. This act by the Government of the Republic of Singapore is therefore inconsistent with the principles adopted in Singapore's own published Aeronautical Information Publication and also goes against the principles of good neighbourliness and that of ASEAN solidarity and understanding.

The Government of Malaysia further reaffirms its categorical objection and rejection of Singapore's continuous issuance of Notice to Airmen (NOTAM) from 0700 hrs to 1900 hrs daily which covers a radius of 3 nautical miles around Batu Puteh and up to an altitude of 2,000 feet which encroaches into Malaysian airspace above the Malaysian territory of Batuan Tengah/Middle Rocks and its maritime area. The issuance of the said NOTAM without prior consent from Malaysia is inconsistent with international law, in particular the Convention on International Civil Aviation (Chicago Convention) 1944. This act by Singapore again goes against the spirit of good neighbourliness and that of ASEAN solidarity and understanding.

The Government of Malaysia calls upon the Government of the Republic of Singapore to withdraw the designation of Restricted Area WSR 31 and issuance of NOTAM with immediate effect. The Government of Malaysia further calls upon the Government of the Republic of Singapore to refrain from designating any Restricted Areas which encroach into Malaysian airspace and from further issuing any NOTAMs which encroach into Malaysian airspace above the Malaysian territory of Batuan Tengah/Middle Rocks and its maritime areas.

Due to the proximity of Tubir Selatan/South Ledge to the mainland of Johor and Batuan Tengah/Middle Rocks, it is clear that Tubir Selatan/South Ledge is located within the territorial waters of Malaysia. It naturally follows that sovereignty over Tubir Selatan/South Ledge belongs to Malaysia in accordance with the Judgment of the ICJ. As such, the Government of Malaysia wishes to remind the Government of the Republic of Singapore that the airspace above Tubir Selatan/South Ledge is part of Malaysia's airspace following the Judgment of the International Court of Justice (ICJ) of 23 May 2008 whereby the ICJ reaffirms Malaysia's sovereignty over Batuan Tengah/Middle Rocks and further stated that "*sovereignty over South Ledge, as a low tide elevation, belongs to the State in the territorial waters of which it is located*".

The Government of Malaysia wishes to also remind the Government of the Republic of Singapore that the airspace over the waters around Batu Puteh, which is located within the territorial waters of Malaysia is part of Malaysia's airspace, in accordance with the principles of international law as well as the Judgment of the ICJ.



The Government of Malaysia further reiterates that any and all activities undertaken by Malaysia in its territory, including activities pertaining to and surrounding the abovementioned airspace and its maritime areas are legitimate exercises of its sovereignty and jurisdiction. As such, Malaysian government vessels and aircraft have and will continue to patrol and conduct their activities in the territorial waters, maritime areas and airspace of Malaysia.

The Government of Malaysia therefore calls upon the Government of the Republic of Singapore to cease and refrain from any intrusions into Malaysian territory, territorial waters and the airspace over its territory and waters.

The Ministry of Foreign Affairs of Malaysia avails itself of this opportunity to renew to the High Commission of the Republic of Singapore the assurances of its highest consideration.



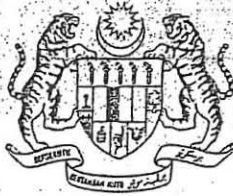

This act by the Government of the Republic of Singapore is therefore inconsistent with the principles adopted in Singapore's Aeronautical Information Publication and also goes against the principles of good neighbourliness and that of ASEAN solidarity and understanding.

The Ministry further reaffirms the Government of Malaysia's categorical objection to and rejection of Singapore's daily issuance of Notice to Airmen (NOTAM) which encroaches into Malaysian airspace above Middle Rocks and its maritime area. The issuance of the said NOTAM without prior consent of the Government of Malaysia is inconsistent with international law, in particular the Convention on International Civil Aviation (Chicago Convention) 1944 and is in fact an abuse of Singapore's administrative powers as the Flight Information Region

authority. This act by Singapore again goes against the spirit of good neighbourliness and that of ASEAN solidarity and understanding.

The Ministry therefore calls upon the Government of the Republic of Singapore to withdraw the designation of Restricted Area WSR 31 and issuance of NOTAM with immediate effect. The Ministry wishes to remind the Government of the Republic of Singapore that the airspace above the waters around Pedra Branca, which is located within the territorial waters of Malaysia, is part of Malaysia's airspace, in accordance with principles of international law as well as the Judgment of the International Court of Justice of 23 May 2008 on the *Case Concerning Sovereignty Over Pedra Branca/Pulau Batu Puteh, Middle Rocks and South Ledge*.

The Ministry therefore calls upon the Government of the Republic of Singapore to cease and desist from intruding into Malaysian territory, territorial waters and the airspace above its territory and waters.

Malaysia reaffirms its commitment to uphold the spirit of the Malaysia-Singapore Joint Technical Committee and to honour and abide by the International Court of Justice Judgement of 23 May 2009 as well as to cooperate in maintaining a calm situation on the ground and preventing incidents in the waters around Pedra Branca, Middle Rocks and South Ledge.

The Ministry of Foreign Affairs of Malaysia presents its compliments to the High Commission of the Republic of Singapore in Kuala Lumpur and has the honour to refer to the incident involving the sand carrier CAI JUN 3, which capsized and subsequently sank on 13 March 2017 in Malaysia's territorial waters off the coast of Johore, at position 01° 25.8714' North (latitude) and 104° 27.3877' East (longitude), approximately 9.3 nautical miles from Tanjung Punggai, Johore.

The Ministry of Foreign Affairs of Malaysia has further the honour to inform the High Commission of the Republic of Singapore that upon receiving reports of the incident from the owner and captain of the sand carrier CAI JUN 3, the relevant Malaysian authorities have undertaken various activities consistent with Malaysia's sovereignty and jurisdiction within its territorial waters. These activities include, amongst others, coordinating activities relating to search and rescue (SAR), and prevention of possible oil spill and marine pollution, as well as the issuance of Notice to Mariners and Notice Receiver of Wreck.

The Ministry of Foreign Affairs of Malaysia would like to draw the attention of the Government of the Republic of Singapore to the illegal activities undertaken by Singapore's agencies, notably the Maritime and Port Authority of Singapore, clearly within Malaysia's territorial waters which violate Malaysia's sovereignty, jurisdiction and territorial integrity under the relevant principles of international laws, in particular the provisions of the United Nations Convention on the Law of the Sea 1982 (UNCLOS 1982). The illegal activities include amongst others, interference with the SAR operations conducted by the relevant Malaysian agencies, and the placement of an isolated danger buoy in Malaysia's territorial waters without Malaysia's prior approval and authorisation.

The Ministry of Foreign Affairs of Malaysia wishes to inform the High Commission of the Republic of Singapore that the Government of Malaysia views with serious concern and strongly protests the illegal activities, as well as any action that would be undertaken or attempted to be undertaken by Singapore's agencies which purports to enforce Singapore's laws within Malaysia's territorial waters. The Government of Malaysia further seeks the cooperation of the Government of the Republic of Singapore to ensure that such illegal activities will not recur in the future.

Such illegal activities constitute serious violation of Malaysia's sovereignty, jurisdiction and territorial integrity contrary to the principles and rules of international law, including UNCLOS 1982, the spirit of good neighbourliness, as well as the spirit of the Malaysia-Singapore Joint Technical Committee on the Implementation of the International Court of Justice Judgment on Pedra Branca, Middle Rocks and South Ledge to cooperate to maintain a calm situation on the ground and prevent untoward incidents in the waters around Pedra Branca, Middle Rocks and South Ledge. The Government of Malaysia seeks the Government of the Republic of Singapore's cooperation to avoid and refrain from undertaking activities that are not helpful towards the common goal of maintaining a calm situation and preventing untoward incidents in the waters around Pedra Branca, Middle Rocks and South Ledge.

The Ministry of Foreign Affairs of Malaysia avails itself of this opportunity to renew to the High Commission of the Republic of Singapore in Kuala Lumpur the assurances of its highest consideration.

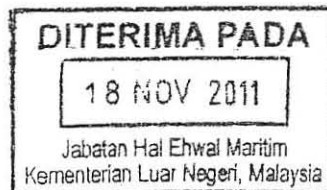

The Ministry of Foreign Affairs of the Republic of Singapore presents its compliments to the High Commission of Malaysia and has the honour to refer to the former's Note MFA/SEA/00035/2011 dated 6 September 2011 protesting 16 intrusions by Malaysian Government vessels into Singapore's Territorial Waters surrounding Pedra Branca which occurred in the period from 5 May 2011 to 30 June 2011, as well as 3 violations of Singapore's Territorial Airspace around Pedra Branca by Royal Malaysian Air Force ("RMAF") B-200T aircraft and a Malaysian Maritime Enforcement Agency ("MMEA") AW-139 aircraft which occurred in the period from 5 June 2011 to 14 June 2011.

The Singapore Government regrets that despite its repeated requests to the Malaysian Government to ensure the cessation of activities by Malaysian Government vessels in Singapore's territorial waters surrounding Pedra Branca which are inconsistent with the bona fide exercise of passage rights, further activities of this nature have been recorded. We refer to the following dates and incidents:

- i. On 6 July 2011 at 0358 hrs, KD Perkasa entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.4 nm of Pedra Branca.



- ii. On 11 July 2011 at 1040 hrs, KD Perkasa entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 5.8 nm of Pedra Branca.
  
- iii. On 27 July 2011 at 1853 hrs, KD Handalan entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.1 nm of Pedra Branca.
  
- iv. On 27 July 2011 at 2346 hrs, KD Handalan entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.2 nm of Pedra Branca.
  
- v. On 2 August 2011 at 0844 hrs, KD Handalan entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 2.2 nm of Pedra Branca.
  
- vi. On 3 August 2011 at 0813 hrs, KD Handalan entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 3.2 nm of Pedra Branca.
  
- vii. On 15 August 2011 at 1204 hrs, KD Perdana entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 5.6 nm of Pedra Branca.

viii. On 18 August 2011 at 0801 hrs, KD Pendekar entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 3.6 nm of Pedra Branca.

ix. On 19 August 2011 at 0020 hrs, KD Pendekar entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.2 nm of Pedra Branca.

x. On 19 August 2011 at 2314 hrs, KD Pendekar entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 3.2 nm of Pedra Branca.

xi. On 22 August 2011 at 1022 hrs, KD Pendekar entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.3 nm of Pedra Branca.

xii. On 23 August 2011 at 0709 hrs, KD Pendekar entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 4.3 nm of Pedra Branca.

xiii. On 23 August 2011 at 1034 hrs, KD Ganyang entered Singapore's territorial waters off Pedra Branca, performed manoeuvres that were inconsistent with transit passage, and came within 3.6 nm of Pedra Branca.

The Singapore Government also wishes to bring to the High Commission's attention the following violation of Singapore's territorial airspace around Pedra Branca by Malaysian Government aircraft:

- i. On 21 July 2011 at 0921 hrs, an RMAF B-200T aircraft entered Singapore's territorial airspace around Pedra Branca at a height of approximately 200 feet. The aircraft performed manoeuvres that were inconsistent with transit passage, and came within 1.0 nm of Pedra Branca.
- ii. On 5 August 2011 at 0813 hrs, an RMAF B-200T aircraft entered Singapore's territorial airspace around Pedra Branca at a height of approximately 2500 feet. The aircraft performed manoeuvres that were inconsistent with transit passage, and came within 0.6 nm of Pedra Branca.
- iii. On 11 August 2011 at 1546 hrs, an RMAF B-200T aircraft entered Singapore's territorial airspace around Pedra Branca at a height of approximately 200 feet. The aircraft performed manoeuvres that were inconsistent with transit passage, and came within 0.2 nm of Pedra Branca.

The Singapore Government strongly protests these incidents, which not only infringe Singapore's sovereign rights over the waters and airspace around Pedra Branca, but also go against the spirit of the Malaysia-Singapore Joint Technical Committee, in particular the mutual agreement between Malaysia and Singapore to honour and abide by the International Court of Justice (ICJ) Judgment of 23 May 2008, wherein the ICJ affirmed that sovereignty over Pedra Branca belongs to Singapore,

as well as the mutual agreement to cooperate to maintain a calm situation on the ground and prevent incidents in the waters around Pedra Branca, Middle Rocks and South Ledge.

The Singapore Government seeks the cooperation of the Malaysian Government to ensure the immediate cessation of incidents of this nature, which are not helpful towards the common goal of maintaining a calm situation on the ground and ensuring safety and security in and around Pedra Branca, Middle Rocks and South Ledge.

The Ministry of Foreign Affairs of the Republic of Singapore avails itself of this opportunity to renew to the High Commission of Malaysia the assurances of its highest consideration.

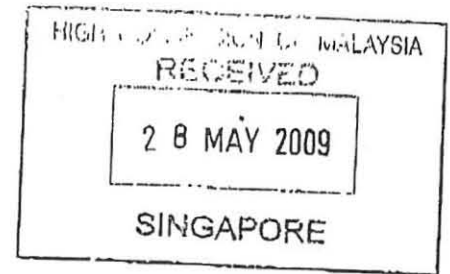

The Ministry of Foreign Affairs of the Republic of Singapore presents its compliments to the High Commission of Malaysia and has the honour to refer to the incident involving a Honduras-registered tanker MT "VERTEX" which caught fire in Singapore Territorial Waters in the East Johor Strait at approximately 1040 hrs on 18 May 2009.

In view of the fact that the incident had taken place in Singapore Territorial Waters, the Maritime and Port Authority of Singapore took charge of the incident, carried out investigations, and conducted the search and rescue operations, including the rescue of fifteen crew members and extinguishing of the fire onboard MT "VERTEX" with the assistance of the Police Coast Guard of Singapore. The Maritime and Port Authority of Singapore also approved the request for permission by the owner of MT "VERTEX" to tow the tanker out of Singapore Territorial Waters to Pasir Gudang.

At 1840hrs on 20 May 2009, a Malaysian Marine Department vessel "Jabatan Laut Altair" proceeded alongside MT "VERTEX" without obtaining permission from the Maritime and Port Authority of Singapore. When approached, "Jabatan Laut Altair" refused to allow the Maritime and Port Authority of Singapore vessel "MPA 2" to proceed alongside it. "Jabatan Laut Altair" stayed in Singapore Territorial Waters until 0910 hrs on 23 May 2009, despite repeated requests from the Maritime and Port Authority of

Singapore for it to leave Singapore Territorial Waters. A Malaysian Police vessel "PA14" was also observed in the area from 0615 hrs on 21 May 2009 till 0910 hrs on 23 May 2009.

The Government of Singapore strongly protests these intrusions by Malaysian Government vessels which had not obtained the permission of the Singapore Government to enter Singapore Territorial Waters. The Government of Singapore also categorically rejects the unjustified attempts by the Malaysian Marine Department craft "Jabatan Laut Altair" to exercise jurisdiction in Singapore Territorial Waters and impeding the Maritime and Port Authority of Singapore from carrying out its responsibilities at the incident site from 20 May 2009 to 23 May 2009. The Government of Singapore seeks the co-operation of the Malaysian Government to ensure the immediate cessation of intrusions by Malaysian Government vessels in Singapore Territorial Waters.

The Ministry of Foreign Affairs of the Republic of Singapore avails itself of this opportunity to renew to the High Commission of Malaysia the assurances of its highest consideration.

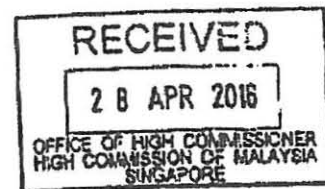

Singapore strongly protests the claim in Port Circular No. 05/2016 that the Dumping Ground is "in Malaysian Territorial Sea off the State of Johor" as the said Dumping Ground encroaches into Singapore territorial waters around Pedra Branca. 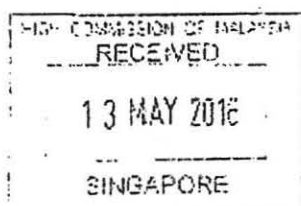

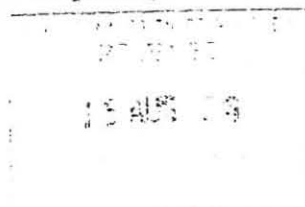

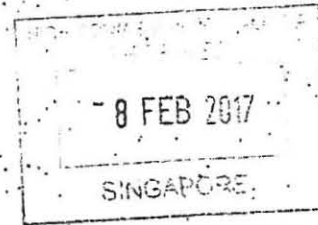

The Government of Malaysia categorically rejects the contentions of the Government of the Republic of Singapore that the Malaysian Government vessels referred to in the abovementioned Note had intruded and exercised jurisdiction in Singapore's purported territorial waters in the southern part of eastern Johor which occurred in the period stated in the said Note from 1840 hrs on 20 May 2009 to 1910 hrs on 23 May 2009.

The Government of Malaysia strongly rejects the assertions by the Government of the Republic of Singapore that the aforementioned Malaysian Government vessels had impeded the Maritime and Port Authority of Singapore from carrying out its responsibilities at the site of the incident involving a Honduras-registered tanker MT "VERTEX" which caught fire in Malaysian territorial waters on 18 May 2009, since the Malaysian Government vessels were patrolling and carrying out their normal duties including investigations, search and rescue operations and ensuring safety of navigation in the territorial waters and maritime areas of Malaysia.

In light of the above, the Government of Malaysia reiterates its strong protest over the presence of vessels belonging to the Government of Singapore in Malaysian territorial waters in the southern part of eastern Johor, including but not limited to the abovementioned incident. The Government of Malaysia wishes to reiterate further its strong protest over the attempts by Singapore Government vessels in carrying out the alleged investigations and conducting search and rescue operations involving the aforesaid MT "VERTEX" which caught fire in the territorial waters and maritime areas of Malaysia without first obtaining permission from the relevant Malaysian Authority.

The Government of Malaysia strongly affirms that the aforementioned fire incident involving the aforesaid MT "VERTEX" occurred in the waters which are part of the territorial waters and maritime areas of Malaysia in accordance with the principles of international law and as depicted in the Map Defining the Boundaries of the Continental Shelf of Malaysia of 1979.

The Government of Malaysia further reiterates that any and all activities undertaken by Malaysia in its territory, including activities pertaining to and surrounding the abovementioned maritime areas and its airspace are legitimate exercises of its sovereignty and jurisdiction. Malaysian Government vessels and aircraft have and will continue to patrol and carry out all their activities in the territorial waters, maritime areas and airspace of Malaysia.

The Government of Malaysia wishes to remind the Government of the Republic of Singapore that the presence of the latter's vessels in Malaysian territorial waters and its aircraft in Malaysia's airspace is inconsistent with international law. The Government of Malaysia therefore calls upon the Government of Singapore to refrain from such intrusions into Malaysian territory, territorial waters and the airspace over its territory and waters.

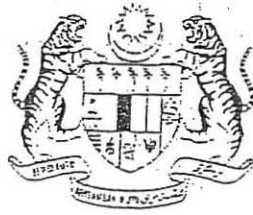

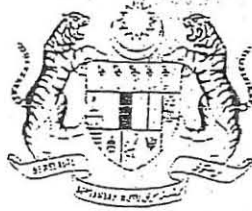

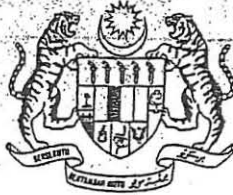
