<u>Allegations of Genocide under the Convention on the Prevention and Punishment</u> of the Crime of Genocide (Ukraine v. Russian Federation)

The Kingdom of Belgium files a declaration of intervention in the proceedings under Article 63 of the Statute

THE HAGUE, 7 December 2022. Yesterday, the Kingdom of Belgium, invoking Article 63 of the Statute of the Court, filed in the Registry of the Court a declaration of intervention in the case concerning Allegations of Genocide under the Convention on the Prevention and Punishment of the Crime of Genocide (Ukraine v. Russian Federation).

Pursuant to Article 63 of the Statute, whenever the construction of a convention to which States other than those concerned in the case are parties is in question, each of these States has the right to intervene in the proceedings. In this case, the construction given by the judgment of the Court will be equally binding upon them.

To avail itself of the right of intervention conferred by Article 63 of the Statute, Belgium relies on its status as a party to the Convention on the Prevention and Punishment of the Crime of Genocide.

Belgium states in its declaration that "the Genocide Convention is an essential instrument for preventing and punishing the crime of genocide". It notes in this regard that "[a]ny act committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group constitutes a crime under international law". Recalling that "the rights and obligations enshrined in the Convention are owed to the international community as a whole", Belgium considers that "the exercise, in the present case, of the right of intervention as provided for by Article 63 of the Statute enables States parties to the Convention to reaffirm both their collective commitment to upholding the rights and obligations contained therein, and the essential role of the Court".

In accordance with Article 83 of the Rules of Court, Ukraine and the Russian Federation have been invited to furnish written observations on Belgium's declaration of intervention.

Belgium's declaration of intervention will be available on the Court's website shortly.

The International Court of Justice (ICJ) is the principal judicial organ of the United Nations. It was established by the United Nations Charter in June 1945 and began its activities in April 1946. The Court is composed of 15 judges elected for a nine-year term by the General Assembly and the Security Council of the United Nations. The seat of the Court is at the Peace Palace in The Hague (Netherlands). The Court has a twofold role: first, to settle, in accordance with international law, through judgments which have binding force and are without appeal for the parties concerned, legal disputes submitted to it by States; and, second, to give advisory opinions on legal questions referred to it by duly authorized United Nations organs and agencies of the system.
