Obligations of Israel in relation to the Presence and Activities of the United Nations,

Other International Organizations and Third States in and in relation to

the Occupied Palestinian Territory

(Request for Advisory Opinion)

Conclusion of the public hearings held from 28 April to 2 May 2025

THE HAGUE, 2 May 2025. The public hearings on the request for an advisory opinion on the Obligations of Israel in relation to the Presence and Activities of the United Nations, Other International Organizations and Third States in and in relation to the Occupied Palestinian Territory concluded today.

During the hearings, 39 States, the United Nations and three other international organizations presented oral statements (in the following order): the United Nations; Palestine; Egypt; Malaysia; South Africa; Algeria; Saudi Arabia; Belgium; Colombia; Bolivia; Brazil; Chile; Spain; the United States of America; the Russian Federation; France; Hungary; Indonesia; Türkiye; Iran; Jordan; Kuwait; Luxembourg; Maldives; Mexico; Namibia; Norway; Pakistan; Panama; Poland; Qatar; the United Kingdom; China; Senegal; Slovenia; Sudan; Switzerland; Comoros; Tunisia; Vanuatu; the League of Arab States; the Organisation of Islamic Cooperation; and the African Union.

The Court will now begin its deliberation.

The Court's advisory opinion will be delivered at a public sitting, the date of which will be announced in due course.

The International Court of Justice (ICJ) is the principal judicial organ of the United Nations. It was established by the United Nations Charter in June 1945 and began its activities in April 1946. The Court is composed of 15 judges elected for a nine-year term by the General Assembly and the Security Council of the United Nations. The seat of the Court is at the Peace Palace in The Hague (Netherlands). The Court has a twofold role: first, to settle, in accordance with international law, legal disputes submitted to it by States; and, second, to give advisory opinions on legal questions referred to it by duly authorized United Nations organs and agencies of the system.
