# SECTION A.—REQUEST FOR ADVISORY OPINION

I.—THE SECRETARY GENERAL OF THE UNITED NATIONS TO THE PRESIDENT OF THE INTERNATIONAL COURT OF JUSTICE

New York, 16 December 1953.

Sir.

I have the honour to inform you that the General Assembly of the United Nations, by a resolution adopted at its 471st meeting held on 9 December 1953, in connection with its consideration of supplementary estimates for the financial year 1953 as they related to the payment of awards of compensation ordered by the Administrative tribunal in the case of some eleven staff members whose appointments had been terminated during 1953, decided to request the International Court of Justice to give an advisory opinion on the following questions:

- "(I) Having regard to the Statute of the United Nations Administrative Tribunal and to any other relevant instruments and to the relevant records, has the General Assembly the right on any grounds to refuse to give effect to an award of compensation made by that Tribunal in favour of a staff member of the United Nations whose contract of service has been terminated without his assent?
  - (2) If the answer given by the Court to question (1) is in the affirmative, what are the principal grounds upon which the General Assembly could lawfully exercise such a right?"

One copy each of the English and French texts of the aforementioned resolutions of the General Assembly, both duly certified, are herein enclosed.

In accordance with Article 65 of the Statute of the International Court of Justice, I shall transmit to the Court all documents likely to throw light upon the question, including the relevant records of proceedings of the General Assembly as soon as the official records are available.

### II.—RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY AT ITS 471st PLENARY MEETING ON 9 DECEMBER 1953

The General Assembly,

Considering the request for a supplementary appropriation of \$179,420, made by the Secretary-General in his report (A/2534) for the purpose of covering the awards made by the United Nations Administrative Tribunal in eleven cases numbered 26, and 37 to 46 inclusive,

Considering the concurrence in that appropriation by the Advisory Committee on Administrative and Budgetary Questions contained in its twenty-fourth report to the eighth session of the General Assembly (A/2580),

Considering, nevertheless, that important legal questions have been raised in the course of debate in the Fifth Committee with respect to that appropriation,

#### Decides

To submit the following legal questions to the International Court of Justice for an advisory opinion:

- "(r) Having regard to the Statute of the United Nations Administrative Tribunal and to any other relevant instruments and to the relevant records, has the General Assembly the right on any grounds to refuse to give effect to an award of compensation made by that Tribunal in favour of a staff member of the United Nations whose contract of service has been terminated without his assent?
  - (2) If the answer given by the Court to question (1) is in the affirmative, what are the principal grounds upon which the General Assembly could lawfully exercise such a right?"
