Communiqué No. 64/4 (Unofficial)

The following information from the Registry of the International Court of Justice is communicated to the Press:

Further to communiqué No. 64/2 of 3 February 1964, the hour fixed for the opening on 11 March of the public hearings in the case concerning the Barcelona Traction, Light and Power Company Limited (New Application: 1962) (Belgium y. Spain) (Preliminary Objections) is 10.30 a.m.

At the beginning of the hearing, the Court will install four new Members who were elected by the General Assembly and Security Council of the United Nations in October 1963. The Judges concerned are Sir Muhammad Zafrulla Khan, Mr. Luis Padilla Nervo, M. Isaac Forster and M. André Gros. A biographical note concerning these Judges is appended to the present communiqué.

The Judges will make the solemn declaration provided for in Articles 20 of the Statute and 5 of the Rules of Court.

Before hearing oral argument in the case concerning the Barcelona Traction, Light and Power Company Limited (Preliminary Objections), the Court will proceed to the installation of M. Enrique C. Armand-Ugon, former President of the High Court of Justice of Uruguay, and M. Walter J. Ganshof van der Meersch, <u>Avocat général</u> to the Belgian Court of Cassation, Professor at Brussels University, who, in accordance with Article 31 of the Statute of the Court, have been designated by the Governments of Spain and Belgium respectively to sit as judges <u>ad hoc</u> in this case.
