These are listed and organised in chronological order, except in certain cases where, for the sake of convenience, two or more documents concerning the same subject have been grouped together. Each document or group of documents is preceded by a brief commentary. The third and final part of the volume contains translations into French of the Supplemental Documents or of the relevant extracts therefrom.
